Mail-order pharmacies are somewhat similar to community pharmacies; one primary difference is the method by which the medications are requested and received. Some customers consider this to be more convenient than traveling to a community drugstore, in the same way as ordering goods online rather than going to a shop.

While many internet pharmacies sell <u>prescription drugs</u> only with a prescription, some do not require a pre-written prescription. In some countries, this is because prescriptions are not required. Some customers order drugs from such pharmacies to avoid the cost and inconvenience of visiting a doctor or to obtain medications their doctors were unwilling to prescribe. Pharmacies offering medication without requiring a prescription and doctor review or supervision are sometimes fraudulent and may supply counterfeit and ineffective and possibly dangerous medicines.

## **TYPESOFONLINEMEDICINEWEBSITES**

Generally, there are three types of online medicine websites. The ability to distinguish between the various types of medical online sites is helpful in understanding the issues in some current cases.

# 1. Pharmacy—only based sites:

First, there are the sites which offer traditional pharmacy services online only. These *pharmacy-only* based sites will only dispense medicine to a consumer who has first obtained a prescription from a doctor and then submits it to the online pharmacy. *Pharmacy-only* sites are the least controversial because they do not actually initiate the drug sale. These sites merely process valid prescriptions which have already been obtained from a licensed practitioner. The most significant legal problem with these sites occurs when the pharmacy fails to obtain the appropriate license for each state where it intends to do business.

# 2. <u>Prescribing based sites:</u>

These sites often employ both pharmacists and doctors. However, they should be distinguished from the web sites that also may employ doctors and pharmacists, but *only* offer medical advice or health related information. Usually the *prescribing based* sites will provide an online doctor visit either through a medical questionnaire or a simultaneous video conference between the doctor and patient. After the patient enters the information and the doctor reviews it, a prescription maybe issued which is then processed at an online pharmacy. Some prescribing based sites are comprised exclusively of physicians who, upon issuing prescription, contract with an online pharmacy to actually dispense the medicine. In many cases, the doctor, pharmacy, and patient are allocated in different states. The strongest criticism of these sites is that an online form or questionnaire, no matter how detailed, simply cannot substitute for a physical exam.

#### 3. Online Drug Shops:

This is an appropriate description because these websites are primarily engaged in the sale f drugs. Here, essentially all a consumer needs to do in order to obtain a controlled substance or any other prescription drug, is simply go to the site, pick out the drug of choice, and make the purchase with a credit card. With these sites, no examination is necessary and no medical questionnaire needs to be answered. *Online drug shops* often operate from foreign countries. Although many consumers do not realize it, *online drug shops* are considered illegal by most law enforcement agencies. Authorities consider these sites to be the most dangerous because of their willingness to sell potentially dangerous controlled substances.

In addition, *online drug shops* often sell drugs that are unapproved for medical use in the United States. The anonymous nature of the Internet, combined with the fact that many of these pharmacies are foreign based, make them very difficult to stop. Infact, the few *online drug shops* that are discovered and shut down often reappear the next day under a different name or address, ready again to do business.

"A qualified pharmacist, while not qualified to prescribe, would know when a drug is particularly dangerous. This is not the same for an online pharmacy," said Dr Rajeev Kumar, general practitioner. There is no specific regulation for online medical sales in the country. We need specific guidelines that take into consideration the realities of the online market.

Of course the risk will vary according to the particular type of online drug sale. Therefore, consumers are not only risking their health when they make these purchases from foreign *online drug shops*, but also, they are potentially breaking the law as well. Don't give any personal information such as a social security number, credit card information, or medical or health history unless you are sure the website will keep your information safe and private.

Given the amazing rise of e-commerce and the Internet's regulation-free environment, it's no wonder that pharmacies and doctors are seeking to take advantage of the new opportunities. However, recent action by several states suggests entrepreneurs need to be extremely cautious when pursuing this new approach to medicine. Online medicine has the potential to offer great benefits to consumers, but it can also lead to very serious health consequences if practiced recklessly. Furthermore, this industry is so new and fast growing that it is not clear which practices are legal and which are prohibited by state or federal law.

Association of Boards of Pharmacy (NABP). The NABP is pushing for the industry to self egulate and has launched a new certification system called VIPPS<sup>TM</sup> (Verified Internet Pharmacy Practice Sites. VIPPS<sup>TM</sup> is a voluntary, 17pointrigorousexamination, "VIPPS<sup>TM</sup> is a voluntary program designed to certify an online pharmacy's preparedness to meet the unique demands of pharmacy practice on the Internet." Before certification is issued, NABP will verify, independently, all pharmacy applications either through on-site inspections or through its computer database of state laws. Infact, the first VIPPS<sup>TM</sup> certifications were recently presented to several major online pharmacies, and already consumer advocates are encouraging consumers to check for the VIPPS<sup>TM</sup> sign when visiting pharmacy websites.
